**Temporary Debris Box Service is subject to the following terms:**

**PROHIBITED MATERIALS:**

- NO hazardous waste. This includes pesticides, paints, solvents, thinners, medical waste or material containing asbestos. For information on the proper disposal of hazardous waste, please contact the Lake County Hotline at (707) 263-1980 ([www.recycling.co.lake.ca.us/HazMobile.htm](http://www.recycling.co.lake.ca.us/HazMobile.htm)).
- NO motor oil, batteries, tires, large appliances, televisions or computer monitors. These materials may be delivered to the Lake County Waste Solutions (LCWS) Transfer Station at 230 Soda Bay Road, Lakeport or arrangements can be made to provide separate pick-up for a fee.

**WEIGHT RESTRICTIONS (Applies Only to Customers in Lake County & the City of Clearlake)**

- 3 cubic yard bin 3-day rental – No heavy items such as dirt, rocks, bricks, and asphalt shingles.
- 15 cubic yard box 5 day rental - The service fee includes the first three (3) tons
- 20 cubic yard box 5 day rental – The service fee includes the first four (4) tons
- 30 cubic yard box 5 day rental – The service fee includes the first five (5) tons
- Concrete, dirt, brick, rock and asphalt boxes can only be filled ½ full, are available in 15 yds or 20 yds, and can only contain 1 commodity

Customers will be charged the current tonnage disposal fee (in addition to the service fee) for boxes exceeding these weights. Boxes must be loaded WATER LEVEL, and 3 yard bins lids must close completely.

**SURCHARGES FOR EXCESS RECYCLABLES:**

- Lake County may impose a surcharge on disposal fees if more than 25% of load contains recyclables. Recyclables include cardboard, newspaper, office and mixed paper, plastic containers, metal and aluminum cans, glass containers, clean wood and green waste, dirt, concrete, and scrap metal. Customers will be charged (in addition to the service fee) the amount of any surcharge that may be imposed by the County. This fee applies to boxes delivered in Lake County and the City of Clearlake ONLY.
- Customers having large volumes of recyclables can arrange for separate containers. Service fees for recyclable containers are discounted.
- Refunds will not be issued for boxes canceled after the driver has been dispatched for delivery.

**DAMAGE WAIVER:**

Clearlake Waste Solutions and its affiliate companies will not be held liable for any damage to asphalt, concrete, brick, wood or earthen driveways, pads, roadways or other surfaces where a debris box is placed or removed.
