**PROHIBITED MATERIALS:**

- NO hazardous waste. This includes pesticides, paints, solvents, thinners, medical waste or material containing asbestos. For information on the proper disposal of hazardous waste, please contact the Mendocino Solid Waste Management Authority at (707) 468-9710 ([www.mendorecycle.org](http://www.mendorecycle.org)).
- NO Toxic wood waste. Treated wood waste includes fence posts, sill plates, decking, guardrails, landscape timbers, patio wood/posts, pilings, railroad ties and more. - NO motor oil, batteries, tires, large appliances, televisions or computer monitors. These materials may be delivered to the Solid Wastes Systems Transfer Station at 3151 Taylor Drive, Ukiah or arrangements can be made to provide separate pick-up for a fee.

- A hauling fee of \$ \_\_\_\_\_ will be payable at the time of delivery or charged to your credit card. This fee will occur for each delivered or exchanged debris box.
- A disposal fee of \$ \_\_\_\_\_ per ton will be payable at time of delivery or charged to your credit card on file or charged to your account at the time of disposal. This is in addition to the hauling fee.
